PIERRE H. BOULLE is Associate Professor of History at McGill University (Montreal). He teaches early modern European history and specializes in French colonial issues and the understanding of race. His forthcoming chapter on “France Overseas” co-authored with D. Gillian Thompson, will appear in May in Volume IV of *The New Oxford History of France* edited by William Doyle. He’s currently working on a monograph of French non-white residents in eighteenth-century France.

ÉRIC DUPIN is an editorial writer for *Libération* and is also a lecturer at the Institut d’Études Politiques (Paris). He is the author of *Cinquante ans de sondages IFOP* (1990), *L’Après-Mitterrand—le Parti socialiste à la dérive* (1991), and *Le Disciple—les dix leçons que Jospin apprit de Mitterrand* (1998). He also contributed to *La France présidentielle*, edited by Nicholas Wahl and Jean-Louis Quermonne (1995).

PHILIP GORDON is a Senior Fellow in Foreign Policy Studies and Director of the Center on the United States and France at the Brookings Institution, which was set up in September 1999. Prior to coming to Brookings he was Director for European Affairs at the National Security Council (1998-99) and Senior Fellow for US Strategic Studies and the Editor of *Survival* at the International Institute for Strategic Studies in London (1994-98). His many publications on France and French-American relations include “The French Position,” *The National Interest* (2000); “Charles de Gaulle and the Nuclear Revolution,” in John Lewis Gaddis, Philip H. Gordon, Ernest R. May and Jonathan Rosenberg, *Cold War Statesmen Confront the Bomb: Nuclear Diplomacy Since 1945* (1999); and *France, Germany and the Western Alliance* (1995).

PAUL JANKOWSKI is currently Associate Professor of History at Brandeis University, and the author of *Communism and Collaboration: Simon Sabiani and Politics in Marseille, 1919-1944* (1989); *Cette vilaine affaire Stavisky. Histoire d’un scandale politique* (2000), forthcoming in English as *Anatomy of a Scandal*. He is currently working on a book about political scandals in France since the Revolution.

LAURENT JEANPIERRE teaches sociology at Université Paris-XII Créteil. He is currently finishing his Ph.D. at the École des Hautes Études en Sciences Sociales on French artists and intellectuals exiled in the United States during World War II. He recently published an article on Varian Fry and American rescue efforts towards refugees in the 1930s and 1940s in *Varian Fry, du refuge ... à l'exil* (2000) and a review essay on Kojève, Sartre, and Bataille in *Critique* (2000). He is presently interested in comparing European cultural and political migrations to the United States after the rise of Nazism.

MICHÈLE LAMONT is Professor of Sociology at Princeton University. She has published widely in the fields of inequality, race, knowledge, theory, and comparative sociology. Her recent publications include *The Dignity of Working Men: Morality and the Boundaries of Race, Class, and Immigration* (2000); *Rethinking Comparative Cultural Sociology: Repertoires of Evaluation in France and the United States* (2000); and *The Cultural Territories of Race: Black and White Boundaries* (1999). She is now at work on a study of antiracist strategies among African American leaders, and on a project on criteria of evaluation of quality in the social sciences and the humanities.

PIERRE LASCOURMES is a Senior Research Fellow at the CNRS and at the Groupe d'Analyse des Politiques Publiques (École Normale Supérieure de Cachan). He is the author of *L'Éco-pouvoir, environnements et politiques* (1994), *L'Administration territoriale l'environnement* (1996) with J.P. Le Bourhis, and *Corruptions* (1999), and of a series of articles on law and public policy, law-making processes, parliaments and the production of legal forms, environmental policies, and political action. He is presently completing a book with Michel Callon, *Décider sans trancher, l'action mesurée face aux incertitudes*.

SOPHIE MEUNIER is Visiting Fellow at Princeton University's Center of International Studies and Lecturer in Public and International Affairs at the Woodrow Wilson School. Her research focuses on the politics of trade policy, transatlantic trade negotiations and, more generally, international political economy. Her recent publications include "The French Exception," *Foreign Affairs* (2000) and "What Single Voice? European Institutions and EU-US Trade Negotiations," *International Organization* (2000). With co-author Philip Gordon, she is currently completing a book on France's adaptation and resistance to globalization.

GISÈLE SAPIRO is a researcher at the CNRS (Centre de sociologie européenne, EHESS-Paris). She is the author of *La Guerre des écrivains* (1999) and of a series of articles on French writers and French literary institutions during World War II, and more generally, on the relationship between literature and politics, among which, "Les conditions professionnelles d'une mobilisation réussie: le Comité national des écrivains," *Le Mouvement Social* (1997); "De l'usage des

catégories de droite et de gauche dans le champ littéraire”, *Société et représentations* (2001). In collaboration with Claire Paulhan, she has published a critical edition of Jean Grenier’s diary, *Sous l’Occupation* (1997). She is now participating in the coordination of the *Dictionnaire biographique du mouvement ouvrier français* for the 1940-1968 volume.

ROBERT SCHWARTZWALD is Professor of French and Francophone Studies at the University of Massachusetts Amherst, where he also directs the Five College Center for Crossroads in the Study of the Americas. He served as editor of *Quebec Studies*, the journal of the American Council for Quebec Studies, from 1996 to 1999, and is currently Editor of the *International Journal of Canadian Studies/Revue internationale d’études canadiennes*. Previous studies on the World War II years include an annotated translation of Daniel Guérin’s *La Peste brune (The Brown Plague: Travels in Late Weimar and Early Nazi Germany)*, translated and with an introduction by Robert Schwartzwald (1994) and work on the sojourn of Father Marie-Alain Couturier, O.P. in North America.

STEVEN UNGAR is Professor of French and Comparative Literature at The University of Iowa, where he also chairs the Department of Cinema and Comparative Literature. His research publications include *Roland Barthes: The Professor of Desire* (1983), and *Scandal and Aftereffect: Blanchot and France Since 1930* (1995). He coedited *Signs in Culture: Roland Barthes Today* (1989) with Betty McGraw and *Identity Papers: Contested Nationhood in 20th-Century France* (1996) with Tom Conley. Current projects include a book on France between the wars and *Urban Subjects*, a study of city scenes and everyday life.

STEVE ZDATNY is Associate Professor of History at West Virginia University. His principal publications are *The Politics of Survival: Artisans in Twentieth-Century France* (1990) and *Hairstyles and Fashion: A Hairdresser’s History of Paris, 1910-1920* (1999). Among his recent articles are “Collaboration or Resistance: French Hairdressers and Vichy’s Labor Charter,” *French Historical Studies* (1997); “The Boyish Look and the Liberated Woman: The Politics and Aesthetics of Women’s Hairstyles,” *Fashion Theory* (1997). He has an article forthcoming “The Mirage: Artisans and Corporatism in the Twentieth Century,” in Steven Kaplan and Philippe Minard, eds., *Corporations and Corporatism in French Society, XVIIIth-XXth Centuries*, and he is currently writing a book on the French hairdressing profession in the era of mass consumption.
