GEORGES BALANDIER is Professor Emeritus at the Sorbonne, directeur d'études at the École des hautes études en sciences sociales, and director of the *Cahiers Internationaux de Sociologie*. He is a regular contributor to *Le Monde des Livres*. His main publications include: *Afrique ambiguë* (1957, 1998); *Anthropologie politique* (1967, 1999); *Anthropo-logiques* (1974, 1985); *Le Détour: pouvoir et modernité* (1985, 1997); *Le Pouvoir sur scènes* (1980, 1992); *Le Dédale: pour en finir avec le XX^e siècle* (1994); and *Le Grand Système* (2001).

STÉPHANE BEAUD is a lecturer in sociology at the University of Nantes and a researcher at the CNRS (Cultures et sociétés urbaines-IRESCO). He is also a research associate in social sciences at the École normale supérieure (Ulm) and a contributor to *Genèses: Sciences sociales et histoire*. His publications include *Guide de l'enquête de terrain*, with Florence Weber (1997); *Retour sur la condition ouvrière*, with Michel Pialoux (1999); and *80% au bac. Et après ?... Les enfants de la démocratisation scolaire* (2002).

ALICE L. CONKLIN is Associate Professor of History at the University of Rochester, where she teaches modern French history, colonial history, and women's history. She is the author of *A Mission to Civilize: The Republican Idea of Empire in France and West Africa, 1895-1939* (1997) and co-editor of *European Imperialism 1830-1930: Climax and Contradiction* (1999). She is currently working on a book on the Musée de l'Homme in Paris between 1920 and 1945. Her article "Civil Society, Science and Empire in Late Republican France: The Foundation of Paris's Museum of Man" appeared in *Osiris* (2002).

FREDERICK COOPER is Professor of History at New York University. He specializes in African history, the history of colonialism, labor history, and the relationship of the social sciences to decolonization. He is the author most recently of *Africa Since 1940: The Past of the Present* (2002) and *Decolonization and African Society: The Labor Question in French and British Africa* (1996). He is also the co-author of *Beyond Slavery: Explorations of Race, Labor, and Citizenship in Post-Emancipation Societies* (2000), and co-editor of *Tensions of Empire:*

Colonial Cultures in a Bourgeois World (1997) and *International Development and the Social Sciences: Essays in the History and Politics of Knowledge* (1997).

OLIVIER MASCLET is a lecturer in sociology at the University of Metz and a researcher at both the ERASE (Metz) and the Centre de sociologie européenne (Paris). His Ph.D. thesis, submitted at the EHESS in 2001 and entitled "Rénovation urbaine et immigration: une intégration sous contrôle. Enquête dans une ville de la banlieue parisienne," will be published in 2003. His articles have been published in *Actes de la recherche en sciences sociales*, *Autrement*, *Cultures et conflits*, and *Genèses*.

ISABELLE MERLE is a researcher in colonial history at the CNRS (CREDO, Marseille) and specializes in the South Pacific. Her research compares British and French colonial systems in the South Pacific area and also explores the field of colonial experiments within the French Empire itself in Algeria. Among her recent publications are: "Drawing Settlers to New Caledonia: French Colonial Propaganda in the Late Nineteenth Century" (in *Promoting the Colonial Idea: Propaganda and Visions of Empire in France*, eds. Tony Chafer and Amanda Sackur, 2002); and "Le voyage de Waktin Tench of the Marine," in a dossier she edited called "Rencontre(s) coloniale(s)," *Genèses* 43 (2001).

FRANÇOIS POUILLON is an anthropologist specializing in the Arab world. He is Directeur d'études at the École des hautes études en sciences sociales (Paris), where he chairs the Centre d'Histoire Sociales de l'Islam Méditerranéen. He studied extensively rural societies in Arab deserts and is currently working on the elaboration of social representations applied to Mediterranean Islam. Among his recent publications are: *Les Deux Vies d'Étienne Dinet, peintre en Islam: L'Algérie et l'héritage colonial* (1997); (ed.) "Enquêtes dans la bibliographie de Jacques Berque," *Revue des Mondes Musulmans et de la Méditerranée* (1997); *La Sociologie musulmane de Robert Montagne* (ed. with Daniel Rivet, 2000).

ANNE RAFFIN is Assistant Professor of Sociology at the National University of Singapore. Her most recent publications include: "The Integration of Difference in French Indochina During World War II: Organizations and Ideology Concerning Youth," in *Theory and Society* (forthcoming 2002); "Domestic Militarization in a Transnational Perspective: Patriotic and Militaristic Youth Mobilization in France and Indochina, 1940-1945," in *Irregular Armed Forces: Their Role in Politics and State Formation*, eds. Diane Davis and Anthony W. Pereira (forthcoming 2002).

EMMANUELLE SAADA is Assistant Director of the Institute of French Studies of New York University. Her field is the historical sociology of French colonization, with a focus on the processes of construction of collective identities within the Empire and their postcolonial legacies. She has published in sev-

eral journals (*Genèses*, *Hérodote*, *French Politics, Culture & Society*, *International Sociology*) and in several edited volumes. She is currently revising a manuscript on the status of *Métis* in the French colonies in the first half of the twentieth century.
