AGNÈS ANTOINE is the former assistant director of the Institute of French Studies at New York University. TERESA HOEFERT DE TURÉGANO is *maître assistante* (assistant professor) in the Cinema Studies department of the University of Lausanne, Switzerland. A former Rockefeller fellow in the Privatization of Culture project at New York
