JOSHUA COLE is Associate Professor of History at the University of Georgia and the author of *The Power of Large Numbers: Population, Politics, and Gender in Nineteenth-Century France* (2000). He is currently working on the history of colonial atrocities in the French empire between 1945 and 1962 and their enduring resonance in the post-independence period.

GÉRARD GRUNBERG is Directeur de recherche at the CNRS and Scientific Director of the Fondation Nationale des Sciences Politiques. He teaches political science at the Institut d'Etudes Politiques in Paris. His published works focus primarily on French and European and the study of elections and representation systems. From 1988 to 1991, he was a member of Prime Minister Michel Rocard's government, where he was in charge of public opinion issues. He was a visiting professor at NYU's Institute of French Studies. He recently co-edited with Nonna Mayer and Paul Sniderman *La Démocratie à l'épreuve, Une nouvelle approche de l'opinion des Français* (2002).

SHERYL KROEN is Associate Professor of History at the University of Florida. She is a specialist of modern European cultural history and the author of *Politics and Theater: The Crisis of Legitimacy in Restoration France, 1815-1830* (2000). She is currently working on a book on the relationship between the consumer and the citizen from the eighteenth century to the present, in France, Germany, England, and the United States.

WILLIAM F.S. MILES is Professor of Political Science at Northeastern University in Boston. His two major works on Martinique are *Elections and Ethnicity in French Martinique: A Paradox in Paradise* (1986) and *De la Politique à la Martinique* (1992). In addition to previous essays in *French Politics, Culture & Society*, his journal articles on Martinique have appeared in *Caribbean Studies*, *Anthropology*, and *Journal of Interamerican Studies and World Affairs*. He also contributed a chapter to *Islands at the Crossroads: Politics in the Non-Independent Caribbean* (2001). Miles's most recent publication on Martinique, "Aimé Césaire and My Jewish Question," appears in *Wadabagei: A Journal of the Caribbean and Its Dias-*

pora 6 (2003). A specialist on the legacies of French colonization worldwide, Professor Miles has also published books on Niger, Pondichéry, and Vanuatu.

PHILIP NORD is Professor of History at Princeton University. He has published three books: *Paris Shopkeepers and the Politics of Resentment* (1986); *The Republican Moment: Struggles for Democracy in Nineteenth-Century France* (1996); and *Impressionists and Politics: Art and Democracy in the Nineteenth Century* (2000). A collection of essays, co-edited with Nancy Bermeo, appeared in 2000 under the title *Civil Society Before Democracy: Lessons from Nineteenth-Century Europe*. He is currently at work on a study of reforming elites in France in the period 1930-1950.

BRUNO PALIER is a political scientist and researcher at the Centre d'études de la vie politique française (CEVIPOF) in Paris. His research focuses primarily on welfare state reforms, both from a French and comparative perspective. His published works include: *La Réforme des retraites* (2003); *Gouverner la Sécurité sociale* (co-edited with Rob S. Sykes and P. Prior, 2002); a collective book, *Globalization and European Welfare States: Challenges and Changes* (2001); and *La Protection sociale en Europe: Le temps des réformes* (with Christine Daniel, 2001).

KERRY H. WHITESIDE is the Clair R. McCollough Professor of Government at Franklin and Marshall College in Lancaster, PA. He is author of *Merleau-Ponty and the Foundation of an Existential Politics* (1998) and *Divided Natures: French Contributions to Political Ecology* (2002). He is currently writing a book on the precautionary principle in environmental risk regulation.
